लोकसभा चुनाव की तैयारी, संघ के संग बीजेपी की अहम बैठक आज

भोपाल.(निप्र)। मध्य प्रदेश के विधानसभा चुनाव में बड़ी जीत हासिल करने के बाद भाजपा लोकसभा चुनाव 2024 की तैयारी में जुट गई है। इसे लेकर भाजपा और राष्ट्रीय स्वयंसेवक संघ के वरिष्ठ पदाधिकारी सीहोर में एकजुट होने वाले हैं। इस बैठक में राज्य सरकार के कामकाज के साथ लोकसभा चनाव पर मंथन होगा और प्रदेश के लिए आगामी चुनाव को लेकर एक रोड मैप तैयार किया जायेगा। मप्र में लोकसभा की २९ सीटें हैं। भाजपा सभी स्थानों पर जीत दर्ज करने की तैयारी में है। पिछले चुनाव में भाजपा के 29 में से 28 सीट पर जीत दर्ज की थी। छिंदवाड़ा संसदीय क्षेत्र पर कांग्रेस के नकुलनाथ जीतने में सफल रहे थे। लोकसमा चुनाव में मध्य प्रदेश में सभी स्थानों पर जीत कैसे दर्ज की जाए। इसकी रणनीति बनाने के लिए ११ जनवरी को सीहोर में एक बैटक होने जा रही है। बैटक में राज्य भाजपा संगटन के प्रमुख विष्णु दत्त शर्मा और संगठन मंत्री हितानंद के अलावा मुख्यमंत्री मोहन यादव और पूर्व मुख्यमंत्री शिवराज सिंह चौहान मौजूद रहेंगे। घ की ओर से प्रमुख पदाधिकारी रहेंगे जिनमें अरुण कुमार, दीपक विस्पुते, राष्ट्रीय महामंत्री बी.एल. संतोष, सह संगठन महामंत्री शिव प्रकाश, क्षेत्रीय संगठन महामंत्री अजय जमवाल हिस्सा लेंगे। इस बैठक में लोकसभावार जिम्मेदारियां सौंपे जाने की तैयारी है। जिसमें राम मंदिर प्राण प्रतिष्टा से जुड़े कार्यक्रमों के जरिए इस विषय को घर-घर पहुंचाने की

भोपाल.(निप्र)। भोपाल रेल मंडल में रेल अधिकारी को सीबीआई ने 15 हजार रुपए की रिश्वत लेते रंगहाथ पकड़ा। सीबीआई आरोपी अधिकारी आधार सिंह के खिलाफ जानकारी जुटा रही है। सीबीआई ने भोपाल रेल नंडल के चीफ लॉ असिस्टेंट आधार सिंह को १५ हजार रुपए की रिश्वत लेते रंगहाथ दबोचा है। आरोपी अधिकारी कार्मिक विभाग में पदस्थ है। वह अपने ही विभाग के एक कर्मचारी सुशील जोशी से जबलपुर कैट में विचाराधीन दो केस को खत्म कराने के लिए रिश्वत मांग रहा था। सीबीआई को सुशील जोशी ने ८ जनवरी को लिखित शिकायत दी थी। इसमें उसने बताया था कि भोपाल रेल मंडल में चीफ लॉ असिस्टेंट आधार सिंह उसके दो केस को डाइल्यूट कराने २० हजार रूपए की रिश्वत मांग रहा है। उसे उनके द्वारा यपीआई नंबर पर पैसे टांसफर करने के लिए कहा जा रहा है। शिकायत में सुशील कुमार ने बताया कि पूर्व डीपीओ अजय कुमार दीक्षित ने उनको प्रताड़ित करने के लिए बिना कारण दो चार्जशीट दे दी थी। इसके विरुद्ध उनके द्वारा कैट जबलपुर में आवेदन दिया था। यह दोनों मामले कैट जबलपर में लंबित है। इन मामलों को लेकर आधार सिंह ने सुशील जोशी को कहा कि लीगल सेक्शन की तरफ से वह दोनों मामलों को कमजोर एवं निराकण करा दूंगा। इसके बाद सीबीआई ने मंगलवार रात को आधार सिंह को रिश्वत लेते रंगहाथ गिरफ्तार कर जांच शुरू कर दी। सीबीआई आधार सिंह की आय और संपत्ति की जानकारी जुटा रही है।
