#### Xi Jinping meets with Lavrov

BEIJING: Chinese leader Xi Jinping met with Russian Foreign Minister Sergey Lavrov in Beijing on Tuesday, Xinhua reported. Details of the meeting were not immediately disclosed by state media. Lavrov is on a two-day visit to the Chinese capital, which follows Russian President Vladimir Putin's suggestion last month of considering China for his maiden overseas trip after his election victory last month.

### Netanyahu escalates pledge to invade Gaza city despite US warning

AP / Jerusalem

Israeli Prime Minister Benjamin Netanyahu has escalated his pledge to invade the southern Gaza city of Rafah, which is filled with around 1.4 million Palestinians, most of whom are displaced from other parts of the Gaza Strip.

"It will happen. There is a date," Netanyahu said in a video statement on Monday, without elaborating.

The United States, Israel's closest ally, has said a ground operation into Rafah would be a mistake and has de manded to see a credible plan to protect civilians. Netanyahu spoke as Israeli negotiators are in Cairo discussing international efforts to broker a cease-fire deal with the Palestinian militant group Hamas.

Israeli troops withdrew Sunday from Khan Younis, another city in southern Gaza, ending a key phase of the war. Defense officials say they're regrouping ahead of a push into Rafah. Palestinians who visited Khan Younis on Monday said the city is now unlivable, offering them little immediate chance to return. Many have been sheltering

## Protect citizens from ill effects of climate change: Int'l court

AP / Strasbourg (France)

Europe's highest human rights court ruled on Tuesday that its member nations have an obligation to protect their citizens from the ill effects of climate change, but still threw out a high-profile case brought by six Portuguese voungsters aimed at forcing countries to reduce greenhouse gas emissions.

The European Court of Human Rights sided with more than 2,000 Swiss members of Senior Women for Climate Protection, who also sought such measures in a mixed session of judgements in which a French mayor similarly seeking stronger government efforts to combat climate change was also defeated.

Lawyers for all three had hoped the Strasbourg court would find that national governments have a legal duty to make sure global warming is held to 1.5 degrees Celsius degrees

Netanyahu has escalated pledge to invade Gaza city despite US warning

Israeli Prime Minister Benjamin Netanyahu has escalated his pledge to invade the southern Gaza city of Rafah. which is filled with around 1.4 million Palestinians, most of whom are displaced from other parts of the Gaza Strip.

"It will happen. There is a date," Netanyahu said in a video statement on Monday without elaborating.

The United States, Israel's closest ally, has said a ground operation into Rafah would be a mistake and has demanded to see a credible plan to protect civilians. Netanyahu spoke as Israeli negotiators are in Cairo discussing international efforts to broker a cease-fire deal with the Palestinian militant group Hamas.

Israeli troops withdrew Sunday from Khan Younis, another city in southern Gaza, ending a key phase of the war. Defense officials say they're regrouping ahead of a push into Rafah. Palestinians who visited Khan Younis on Monday said the city is now unlivable, offering them little immediate chance to return.

**UNITED NATIONS:** India has termed the UN Security Council resolution that demanded immediate ceasefire in Gaza for the month of Ramadan a "positive step," asserting that the humanitarian crisis resulting from ongoing Israel-Hamas conflict is "simply unacceptable." 'We are deeply troubled by the ongoing conflict in Gaza. The humanitarian crisis has deepened and instability has been increasing in the region and beyond," India's Permanent Representative to UN, Ambassador Ruchira Kamboj, told a UN General Assembly meeting.

of 40 Hamas-held hostages for at least 700 Palestinians The proposal was presented to delegations from Hamas and Israel during the latest round of negotiations in Cairo over the weekend, according to the officials, who spoke on condition of anonymity to discuss the negotiations.

Among the Palestinian prisoners to be freed would be dozens convicted of Israelis during killing attacks by militant groups.

The officials said Hamas would be required to provide a list of the hostages it will release, as well as a list of Palestinian prisoners whose freedom it seeks.

The proposal also includes the return of a significant number of Palestinians to northern Gaza. Hundreds of thousands of Palestinians fled the northern half of Gaza in the early stages of the war, heeding Israeli evacuation orders. The vast maiority of Gaza's 2.3 million people are now crammed into the southern half.

The proposal stipulates that Israel gradually dismantle checkpoints it had built on a new road that split the strip in half to prevent the return of Palestinians to the north.

Europe's highest human rights court ruled on Tuesday that its member nations have an obligation to protect their citizens from the ill effects of climate change, but still threw out a high-profile case brought by six Portuguese voungsters aimed at forcing countries to reduce greenhouse gas emissions.

The European Court of Human Rights sided with more than 2,000 Swiss members of Senior Women for Climate Protection, who also sought such measures in a mixed session of judgements in which a French mayor similarly seeking stronger government efforts to combat climate change was also defeated.

Lawyers for all three had hoped the Strasbourg court would find that national governments have a legal duty to make sure global warming is held to 1.5 degrees Celsius (2.7 degrees Fahrenheit) above pre-industrial levels, in line with the goals of the Paris climate agreement.


