Asked why her daughter may have raised the slogans, Rina said," Someone could have tutored her"

Legal experts The Free Press Journal spoke with, however, felt that the sedition charges were unwarranted and would not hold up in court. "The students have only raised slogans in support of Sharjeel Imam and not against the government. In fact, there is a judgment of the apex court wherein it has held that only raising slogans cannot constitute sedition unless there is an implicit threat of violence. This section is being invoked misused grossly against every person who holds an opinion against CAA etc," said senior counsel Aspi Chinoy.

Similarly, advocate Dr Sujay Kantawala opined that merely raising slogans

said they had formed sev eral teams to trace Chudawala, whose social media accounts were also found to have been deactivated. The police said they were aware of two mobiles numbers Chudawala has been using, but she did not answer calls placed to both numbers.
